ORDER

Tvl. Coastal Plastochem (P) Ltd., Chennai - 600007 (TIN.No. 33270483294), the registered dealers in the files of Purasawalkam Assessment Circle have preferred application in Form 'VV' and sought clarification under Section 48-A (1) of the TNVAT Act, 2006, read with Rule 12-A of TNVAT Rules, 2007.

2.1. The applicant-dealers have sought for clarification on the following:

Rate of Tax on "Calcium Carbide"

- 2.2. The applicant-dealer stated that they were chemical manufacturers and the Calcium Carbide is used in Generation of Acetylene gas, which is used for welding.
- 3. The issue has been examined in detail with reference to the provisions of TNVAT Act, 2006 and Rules 2007 and the relative entries regarding the commodities classified under the First and Fourth Schedule to the TNVAT Act, 2006. Section 48-A of TNVAT Act, 2006 provides for clarification on any point concerned with rate of tax for commodities.
- 4. The applicant dealer had sought for clarification regarding rate of tax on "Calcium Carbide". There is no specific/relevant entry in any of the schedules to the TNVAT Act, 2006, relating to Calcium Carbide. The "Calcium Carbide" is a chemical compound with the chemical formula of CaC2. Its main use industrially is in the production of acetylene and calcium cyanamide. Hence it is construed that the "Calcium Carbide" can be classified under Entry in S.No.1 with the description "Acid and chemicals of all kinds other than those specified elsewhere in the schedule" of Part-B of First Schedule to the TNVAT Act, 2006 and are liable to tax @ 5%.
- 5. It is therefore clarified that "Calcium Carbide" is liable to tax at 5% as a "Chemical" under Entry 1 of Part-B of First Schedule to the TNVAT Act, 2006.
