In exercise of the powers conferred by sub-section (4) of section 5 of the Goa Value Added Tax Act, 2005 (Goa Act 9 of 2005) (hereinafter referred to as the "said Act"), and all other powers enabling it in this behalf, the Government of Goa hereby amends Schedules 'B' and 'E' appended to the said Act, as follows, namely:—

(I) In Schedule 'B' appended to the said Act, after entry at serial number (162), the following entry shall be inserted, namely:—

"(163) Sanitary napkins and diapers including adult diapers.".

(II) In Schedule 'E' appended to the said Act, for the existing entry at serial number

(5), the following entries shall be substituted, namely:—

"(5) Works contractor who undertakes the work of construction of flat/s, dwelling unit/s, house/s, row houses, building/s or premises and transfers them in pursuance of an agreement alongwith land or interest underlying the land, where the aggregate amount of consideration of such flat, dwelling unit, house or row house, building or premises specified in such agreement,—

(i) does not Not Nil exceed Rs. 20 lakhs applicable

(ii) exceeds Rs. 20 Not 0.5% lakhs but does not applicable exceed Rs. 50 lakhs
