Government, in the course of implementation of the recommendations of the Cabinet Sub-Committee(CSC) on the grievances of Transporters JAC, have issued orders in the reference 9th cited, waiving the VAT arrears due from the Oil Tankers on the transactions of transfer of right to use for the period from 08-11-2011 to till date i.e., 30-09-2015.

- In the reference 10^{th} cited, the Transporters JAC represented before the Government that the waiver may be extended for 45 to 60 more days so that the modalities for tax deduction at source are worked out and implemented by the Oil Companies in consultation with the authorities concerned.
- Government after careful consideration of the request of the Transporters JAC, and considering the recommendation of the CSC "the VAT (Lease Tax) levied from 08-11-2011 till date may be waived and the future taxes are to be collected from the Oil Companies by deducting the tax at source from the bills payable to the oil tankers. Suitable provisions to be made", hereby order that for para-4 of the Govt. Memo. No.14506/CT-II(1)/ 2015-2, Dated:05-10-2015, the following may be read:

"In pursuance of the recommendation of the Cabinet Sub-Committee and the orders issued thereon in the reference 8th cited, Government hereby order to waive all the VAT arrears due from the Owners of Oil tankers on the transactions of transfer of right to use (Lease Tax) from 08-11-2011 till the TDS provisions on purchases and sales in the APVAT Act come into force".

The Commissioner of Commercial Taxes, Andhra Pradesh, Hyderabad is requested to take necessary action accordingly.
