

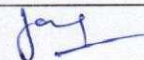

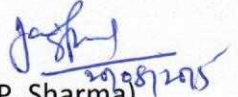
2. The officers at Sr. Nos. 12, 26, 27, 30 & 56 have been retained in their present place of posting till AGT-2016.
