OFFICE ORDER NO. 74 /2014

The President is pleased to promote the officers mentioned in **Annexure-I** to the grade of Assistant Commissioner of Customs & Central Excise in Pay Band 3 with Grade Pay of Rs 5400/- on purely *ad-hoc* basis with immediate effect and until further orders.

2. The promotions to the grade of Assistant Commissioner of Customs and Central Excise made are purely on *ad-hoc* basis and does not confer any right on the officers so promoted for any claim for continued officiating or regular promotion in the grade of Assistant Commissioner and the period of such service shall not count for seniority or as qualifying service for further promotions. Government reserves the right to terminate the *ad-hoc* appointment and revert the officers to the post from which he/she was promoted.

3. The *ad-hoc* promotions of the officers mentioned in **Annexure-I** shall be initially on *in-situ* basis, till the time their posting orders on *ad-hoc* promotion are issued as per the Transfer Policy.

4. The *ad-hoc* promotion shall be subject to the decision of the Competent Authority for regular promotion based on UPSC's recommendation.

5. The Chief Commissioners / Directors General, CBEC concerned shall ensure that if any of the officers whose name has figured in **Annexure-I** to this order **is under suspension or facing any charge sheet or prosecution**, he / she **should not be allowed** to assume charge of the post of Assistant Commissioner and this fact should be reported to the Board immediately. Further, if any of the officers figured in **Annexure. I** is undergoing any penalty, he/she should be allowed to assume the charge of the post of Assistant Commissioner only after the expiry of the currency of the penalty period. This fact may also be reported to the Board.
