2. The promotions of the above mentioned officers to the grade of Deputy Commissioner of Customs & Central Excise is purely on ad-hoc basis subject to the orders for regular promotion by the competent authority based on the recommendations of the DPC for regular promotion.

3. The adhoc promotions of the above mentioned officers to the grade of Deputy Commissioner of Customs & Central Excise shall not confer any right on the officers so promoted for any claim for regular promotion in the grade and the period of such service shall not count for seniority or as qualifying service for further regular promotions.

4. The officers being promoted through this Order shall assume charge of the post of the Deputy Commissioner in the same office in which they are currently posted.

5. The Chief Commissioner/DGs shall ensure that if any of the officers whose name figure in the promotion list is under suspension or facing any charge sheet or prosecution, he/she shall not be allowed to assume charge in the grade of Deputy Commissioner and this fact may be brought to the notice of the Board. Further, in respect of officers undergoing penalty, if any, the promotion may be given effect only after the expiry of the currency of the penalty in terms of DoP&T's OM No. 22074/5/2004-Estt.(D) dated 15.12.2004.

6. All the promotee Assistant Commissioners who are being promoted on ad-hoc basis to the grade of Deputy Commissioner shall furnish an undertaking, in duplicate to the concerned Chief Commissioner/DG before assuming charge of the post of the Deputy Commissioner, to the effect that excess salary paid to them on account of this promotion will be recovered in the event of their promotion to the grade of Assistant Commissioner on regular basis with effect from panel year subsequent to 2009, i.e. the year in which they were promoted as Assistant Commissioner on adhoc/notional promotion. One copy of the undertaking may be placed in the Service Book of the officers concerned and another copy be sent to the Board for record, within seven days positively.

7. Officer(s) who are presently on deputation will be considered for actual promotion to the grade of Deputy Commissioner on adhoc basis only after they have reported to the cadre.
